

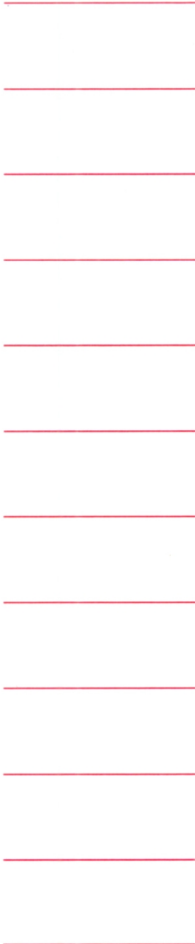

FARMERS MARKET - We celebrated our 11th season of the St. Johns Farmers Market. Our daily customer counts averaged over 2,000 shoppers each week. This was the first year that arts and craft vendors we invited on a full time basis. We enrolled 74 households in our "Veggie Voucher" program that distributes \$20/month vouchers to low income families.

ECONOMIC DEVELOPMENT - We distributed approximately \$26,000 in storefront improvement grants to small businesses. We also partnered with other local organizations to provide coaching and support to local area businesses. Additionally, we connected hundreds of neighbors to local jobs through our jobs board and Meet the Employer events. We also continued our transportation advocacy to increase bus services on certain routes.

COMMUNITY PROGRAMS - Our artBURST series has continued to grow and thrive with our quarterly Art Walk and Art Constitutional events. Through these programs we have supported local artists and attracted thousands of neighbors to our business district to engage in the arts. We also provided essential services to neighbors in-need, including distributing thousands of clothing items to people through our community clothing closet. Our Homeless outreach team helped launch the "St. Johns Welcomes the Village Coalition" bringing together over 200 neighbors in support of a transitional tiny-house village to be built in St. Johns. We have also supported "SummerWorks" which helped place 22 neighborhood interns in local businesses.
